**e- Government Procurement (e-GP) NOTICE INVITING TENDER**

The Managing Director, Kerala State Mineral Development Corporation Ltd., Trivandrum (KEMDEL) invites tenders from experienced contractors/ agencies/ Individuals for the work at WALAYAR dam by removing unfiltered sand using mechanical equipment such as hydraulic excavator or similar sophisticated machine and stacking the materials in measurable form.

**(I) DETAILED SCOPE OF WORK:**

The scope of work consists removing unfiltered sand (approximately 5000 cubic metres) using mechanical equipment such as a hydraulic excavator or similar sophisticated machine and stacking the materials in a measurable form (trapezoidal shape) at the Walayar Dam Catchment area. If the filtered sand is kept in a separate stack per our supervisor's instructions.

**(II) TENDER COST & EARNEST MONEY DEPOSIT (EMD)**

- The bidder should remit the tender cost and EMD.
- E.M.D of the unsuccessful tenders will be refunded without any interest on finalization of the contract with the successful Tenderer or on the expiry of the validity period whichever is earlier. The tenders submitted without EMD in the aforesaid manner will be summarily rejected.
- E.M.D deposited with the owners will be forfeited
  - If a bidder withdraws his bid during the period of validity specified.
  - If the successful bidder fails within the time limits to furnish the required security deposit and execute the agreement or fails to start the work.

**(IV) Pre qualification Criteria**

- a) The Tenderer should have Hydraulic Excavator and other allied equipment's or legally binding Commitment from the owner of the Hydraulic Excavator for making available the same for the work or an undertaking on stamp paper worth Rs 200 should be submitted that, if the bidder is selected as L1, Hydraulic Excavator as per above requirement will be on lease within 2 days from the date of selection notice.

**(V) SELECTION CRITERIA**

Company reserves the right to award the work to the lowest or other tenderers. All items of work in the tender/price part (**BOQ**), being of an integrated nature, all the items of work shall be awarded to a single contractor.

All the items of work being of an integrated nature, evaluation of the tender for the purpose of deciding L1 shall be by deriving the total contract value based on the rates quoted. No claim shall be entertained in case of variation in estimated quantity of any particular item/ items due to reasons whatsoever which may arise after the award of contract and / or during the contract period, on the method of evaluation. Decision of the company in this regard shall be final and binding on the tenderers.

**(VI) A. Technical Bid (Cover 1)**

The following documents should be uploaded in the Technical bid:

- b) Self-certified certificate regarding acceptance of the terms and conditions prescribed in the bid documents.
- c) Technical Bid document duly signed and stamped on all pages.
- d) GST Registration certificate and PAN card.
- e) Documentary evidence of the ownership of the Hydraulic Excavator and other allied equipment's or legally binding Commitment from the owner of the Hydraulic Excavator for making available the same for the work or an undertaking on stamp paper worth Rs 200 should be submitted that, if the bidder is selected as L1, Hydraulic Excavator as per above requirement will be furnished on purchase or on lease within 2 days from the date of selection notice.
- f) Signed and Scanned copy of Preliminary Agreement in Kerala stamp paper worth Rs. 200/-

**(VII) FINANCIAL BID (BOQ IN .xls)**

BOQ shall contain the following values in addition to the jobs mentioned in detailed scope of work.

Excavating, transporting, and depositing the unfiltered sand to the yard, including the hire and operational charges of the earthmoving equipment, all vehicles, trucks, all T&P accessories, crew charges providing, shifting, all labor charges, leveling the yard from time to time to facilitate mobilization of machineries, clearing obstructions in the basin bed, providing necessary safety, fencing, etc., and the excavated material should be stacked in measurable form (Trapezoidal).

**The unit rate quoted should be per Cubic Meter.**

**(X) RETENTION AMOUNT**

- i. All statutory payments in connection with the employment of the workmen for this work will be borne by the Contractor.
- ii. All statutory deductions like works contract tax etc. as applicable shall be made from the amount eligible to the contractor in each part bill at rate applicable at the time of effecting payment. The rate of statutory deduction shall be changed if the government revises the rate. Any tax omitted, to be deducted in any part bill shall be deducted in the subsequent bills / final bill. No compensation shall be paid to the contractors for any variation in the percentage of statutory taxes, levies or duties or for introduction in the percentage of statutory taxes, levies or duties or for introduction of new taxes and levies

**(XI) PERIOD OF VALIDITY**

The tender shall remain valid for acceptance for a period of **30** days from the date of opening of the price bid of the tender. If any tenderer withdraws his tender before the said period or makes any modifications in terms and conditions of the tender, then the "Kerala State Mineral Development Corporation Limited" has the liberty to forfeit the said Earnest Money Deposit.

**(XII) INSPECTION OF SITE**

Every tenderer is expected to inspect the site of the proposed work and acquaint him with the site conditions of substrate, approaches, availability of raw materials, geological and weather conditions, etc., before quoting his rates. He must go through all specifications and other tender documents. Any further clarifications in the documents can be had from the office at the above mentioned address.

**(XIII) QUANTUM OF WORK**

1. Approximately 5000 cubic metres of unfiltered sand were excavated and stacked at Walayar Dam under the supervision of KEMDEL officials.
2. A schedule of approximate quantities of item accompanies this tender. It shall be definitely understood that the “KERALA STATE MINERAL DEVELOPMENT CORPORATION LIMITED” do not accept any responsibility for the correctness or completeness of this schedule in respect of the quantities and this schedule is liable to alteration by deletions, deductions or additions at the discretion of the KERALA STATE MINERAL DEVELOPMENT CORPORATION LIMITED” without affecting the terms of the contract.
3. The “KERALA STATE MINERAL DEVELOPMENT CORPORATION LIMITED” reserves the right to increase or decrease the quantum of work at the site without assigning any reason thereof.
4. Variations in the quantities given in the tender will not be the basis of any claim or disputes. The rates agreed by the contractor shall hold good for any amount of variation in the quantities and no claims whatsoever will be entertained on this account. The contractor shall carry out all works as directed by the *KEMDEL officials* at the same agreed rates.

**(XIV) ALL INCLUSIVE RATES**

The contractor’s rate must be firm throughout the contract period and include the cost of excavation and transportation of equipment’s to the site and all taxes as applicable and the fixing or placing in position for which the item of work is intended to be operated. The rates quoted by the contractor shall be firm throughout the contract period and there shall be no upward revision of the rates quoted by the contractor for any.

**i. PAYMENT TERMS**

The payment for this work will be released only after the members of the core committee inspect and verify the quantity stacked. The bidder is responsible for the security of this unfiltered sand stack.

**GENERAL TERMS & CONDITIONS**

1. All statutory certificate of the mechanical equipment such as a hydraulic excavator or similar sophisticated machine including insurance of the dredger & complements and associated machinery is the responsibility of the contractor and no claim whatsoever will be honored by Kerala State Mineral Development Corporation Limited.

2. The mechanical equip should be operated as per the directions of the officials of Kerala State Mineral Development Corporation Limited at the site /instructions from Kerala State Mineral Development Corporation Limited.
3. The EMD shall be valid for twenty-eight (28) days beyond the original validity period of the bid, or beyond any period of extension if requested.
4. To assist in the examination, evaluation, and comparison of the bids, and qualification of the Bidders, KEMDEL may, at its discretion, ask any Bidder for a clarification of its bid given a reasonable time for a response. Any clarification submitted by a Bidder that is not in response to a request by the Employer shall not be considered. The KEMDEL's request for clarification and the response shall be in writing or by e-mail. No change, including any voluntary increase or decrease in the prices or substance of the bid shall be sought, offered, or permitted.
5. If KEMDEL feels the highest Evaluated Bid Price, is seriously unbalanced or, front loaded in the opinion of KEMDEL, KEMDEL may require the Bidder to produce details stating for such high amount of bid ,to demonstrate the internal consistency of those prices with the excavating method and schedule proposed.
6. The envisaged quantity of silt in BOQ is only provisional.
7. The Excavation proceeds can be removed only up to original contour level at the time of impounding reservoir.
8. The bid amount is for the sediments to be removed and disposed of by the bidder for the envisaged quantity in BOQ. Decision pertaining to the variation if any that had occurred to the envisaged quantity of sediments, the same will be left to KEMDEL regarding the variation of quantity of sediments and its payment to be effected shall be totally binding upon the bidder.
9. Contractor to satisfy himself about site conditions: The Contractor ensures that before submitting bids for the excavating the Contractor has visited the Site and satisfied himself about the Site conditions for dredging and for logistics and smooth flow of workmen and materials as well as permission from KEMDEL for this purpose. The Contractor has examined the Site and taken note of character of the soil and of the excavations, the information of the Work, and facilities for obtaining any special articles called for in the Contract Documents. The Contractor has also made its own assessment and obtained all information on the Site constraints and on all matters that will affect the execution, continuation and progress, and completion of the dredging. Any extra claims or extension of time made in consequence of any misunderstanding, incorrect information on any of these points or on the grounds of insufficient description or information shall not be entertained or allowed at any stage.
10. The contractor shall be responsible for safety & security of the excvator, and the safety of the site and pollution free operation.
11. Kerala State Mineral Development Corporation Limited will not be liable for any overtime wages to the staff of the dredger or other equipment's.
12. The date of commencement of work will be taken as the actual date of taking over the site by the contractor or 5(Five) days from the date of execution of agreement, whichever is earlier and the period of completion of 15 days will be computed from this date.
13. The rate will be inclusive of providing temporary bunds / protection bunds, service taxes, mobilization charge and all statutory recoveries in force and that enforced by the legislature and the parliament as the case may be in future.
14. The excvating should be done without causing any damages to the adjacent structures and the excavated material should be deposited in pre-defined places.

15. If the agreement is not executed within the time limit specified, further action in the matter will be taken as per rules in concurrence with Government.
16. This Tender Document will form part of the agreement.
17. No detention charges or compensation for delay due to break down etc. will be paid by KEMDEL
18. Fuel required for the machineries shall have to be arranged and at the cost of the contractor.
19. It will be responsibility of the contractor to take proper care of safety and security of the Mechanical equipments and its crew during the period of its stay at the site.
20. Necessary permission regarding transportation of stores, fuel, spares, provision, crew change etc. shall be granted or arranged.
21. IT / CESS as applicable from time to time shall be deducted from the amount payable to the contractor. Exemption, if any available shall be produced by the contractor before effecting payment of bills.
22. KEMDEL the Employer reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to Bidders. In case of annulment, all bids submitted and specifically, bid securities, shall be promptly returned to the Bidders.
